

Debt Recovery Services

We set out below brief details regarding our relevant cost structures for business clients for this type of work and other factors that may need to be taken into account when assessing overall potential costs. Our legal costs include:

- Taking instructions and reviewing documentation as necessary to pursue the claim.
- Undertaking appropriate HM Land Registry ownership searches against the debtor's linked addresses.
- Commissioning trace and/or pre-sue (status) enquiries in relation to the debtor where necessary.
- Undertaking appropriate insolvency searches against the debtor. If the debtor is insolvent or financially distressed, the prospect of a successful recovery may be substantially prejudiced
 Sending a letter before action.
- Receiving payment and forwarding this onto the client.
- Negotiating and monitoring instalment arrangements.
- If the debt is not paid further to service of a letter of claim, drafting and issuing formal court proceedings and/or where applicable, serving the debtor with a statutory demand.
- Where no acknowledgement of service or defence is received, applying to the court to enter judgment in default.
- When judgment in default is received, contacting the debtor to further request payment.
- If payment is not received within 14 days or the debt is disputed, providing the client with advice on next steps and updated costs information.

Timescales

We aim to process all instructions within 48 hours of receipt. The actions taken will determine the time it takes to resolve a matter. Straightforward matters should be concluded anywhere between 2 - 8 weeks, but the process may be longer if further action is required.

Explanatory Notes

Anyone wishing to proceed with a claim should note that:

- The vat element of our fee may not be reclaimable from the debtor.
- Interest may take the debt into a higher banding with a higher cost.
- In normal cases the expectation is that the debtor will pay some of your costs. However, this may not be possible. We will seek to recover whatever costs we can on your behalf but please note that you will remain liable for our costs and charges irrespective.
